The mission of our market is to support our local area farmers and provide affordable produce to the public.

Policies and Regulations

- **All goods and produce must be grown, harvested or processed by person(s) seeking an application to sell, within Sawyer or contiguous counties.**
- **Vendors are not allowed to purchase produce or goods from other growers and resell them at the market.**
- **Limited stall spaces are available on a first come first serve basis. Any conflict will be resolved by the FM.**
- **All vendors must complete an application and receive a copy of Policies and Regulations.**
- **The FM Market opens at noon and closes at 4 P.M. every Monday. Vendors are encouraged to come earlier to allow for setting up. Vendors must provide their own tables and display items.**
- **Stalls are limited to approximately 2 parking spaces.**
- **Vendors are responsible for keeping their sites clean and orderly. All garbage and refuse must be hauled away and not placed in FM's dumpsters.**
- **All vendors must comply with all state, county and city regulations and licensing, especially for any processed product.**
- **Vendors are required to secure their own permits necessary and encouraged to have liability insurance. Northern Lakes Co-op will not be responsible for any accidents, injuries, thefts or lost property occurring during the market hours.**
- **Dets are allowed but must be leashed due to our normal K-9 clientele during business hours.**
- **All questions, concerns, complaints may be directed to Northern Lakes Feedmill. All problems will be handled through the FM who will then make the final decision.**
